

NOTICE TO BIDDERS

Hanover Township Road District ("HTRD") is accepting sealed bids for the HTRD's resurfacing and reconstruction of township roads in the Gromer Road Subdivision located in Cook County, Illinois, in strict compliance with the Project Manual, Plans, Specifications, and Drawings prepared by SPACECO, Inc. (the "Engineer") and other Contract Documents as defined in the General Conditions (the "Project Work"). Copies of said bid documents may be obtained by IDOT prequalified bidders (as set forth below) from the Hanover Township office, 250 Il Route 59, Bartlett, IL 60103 during regular business hours of 9:00 a.m. to 4:30 p.m. Monday through Friday, excluding holidays, beginning July 20, 2015 for a non-refundable fee of \$30.00.

Sealed bids must be submitted on forms furnished by the HTRD, and will be accepted at the HTRD office, 250 South Route 59, Bartlett, Illinois 60103 (the "HTRD Office"). Attention: Katy Dolan Baumer, Road District Clerk until 9:00 a.m., August 3, 2015, at which time said bids will be publicly opened and read aloud. Each bid must be accompanied by a bid bond, certified check, cashier's check or bank draft in an amount equal to ten percent (10%) of the bid amount made payable to Hanover Township Road District. All bidders shall be prequalified with IDOT to perform similarly sized HMA bituminous paving projects. Bidders do not need to be prequalified with IDOT for Bituminous Plant Mix nor do bidders need to have their own plant to bid and/or perform this project. No tonnage restriction shall apply to this contract. All bidders should include their IDOT "Certificate of Eligibility" with their bid proposal. The Prevailing Wage Act (820 ILCS 13001, et seq.) shall apply to the Project Work.

The successful Bidder for the Project Work will be required to submit: (1) Payment Bond and Performance Bond or IDOT Contract Bond each in the amount of 110% of the Contract Sum, naming the Hanover Township Road District as primary obligee, in form acceptable to the HTRD, co-signed by a surety company authorized by the Illinois Department of Insurance to sell and issue sureties in the State of Illinois, or (2) an irrevocable Letter of Credit in the amount of 110% of the Contract Sum guaranteeing Contractor's obligations under the Contract Documents issued by a financial institution with at least \$40,000,000 in assets and a capital to asset ratio of not less than 6% in form acceptable to the HTRD, to guaranty the performance of contractor's obligations under the Contract Documents and the payment of all labor and materials furnished for the Project Work. The cost of said Bond or Letter of Credit shall be included in the total bid amount set forth in the Bid Proposal.

It is anticipated that the HTRD will award the Contract to the successful Bidder on or about August 11, 2015. The Project Work, including but not limited to all restoration work must be performed in strict compliance with the Contract Documents and must be completed on or before October 30, 2015, weather permitting.

HTRD reserves the right to reject any and all bids, accept all or part of a bid, and to waive minor irregularities and nonconformities in any bid when it is in the best interests of the HTRD.
