Applicant acknowledges that the work in question will be subject to the right of inspection and approval of the Highway Commissioner, Hanover Township Road District, and that any work not performed in accordance with the "Subdivision Standards for Hanover Township Road District" effective September, 1990, as well as with the "Standard Specifications for Road and Bridge Construction," adopted on October 1, 1983, Illinois Department of Transportation, may be rejected and ordered re-done.
10. Applicant further agrees to return the Work Site to a clean and orderly condition.
11. Applicant swears the above statements are true and correct, under penalties of perjury, and that the same are to induce the Highway Commissioner, Hanover Township Road District, to issue his construction Permit.
12. Applicant agrees to defend, indemnify and save harmless the Hanover Township Road District, its Highway Commissioner, officers, employees, agents, consultants, and volunteers while acting on behalf of the Road District, from and against any and all loss or liability, including, without limitation, claims for mechanic's and materialman's liens, bodily injury, or property damage resulting from or arising out of the acts, omissions and work performed by Applicant and its contractors or any of them upon the roads and highways of Hanover Township, or pursuant to this application.

As a prerequisite to any recovery therefore from Applicant, the road District shall give written notice to Applicant of any such claim or the commencement of any such actions, suits or notice thereof.

13. Applicant or a contractor hired by Applicant shall at all times maintain in effect a policy or policies of insurance, or self-insurance, with policy limits, including umbrella coverage, of not less than \$500,000 combined single limit, naming the Hanover Township Road District, its Commissioner, officers, employees, agents, consultants, and volunteers while acting on behalf of the Road District, as additional parties insured and shall furnish the Road District with a Certificate of Insurance evidencing such coverage prior to commencing any construction work on any roads and highways in Hanover Township.

14. Permit Fee: A \$25.00 culvert Construction Permit Fee shall be paid when the completed application is returned to the township office.
