Clerk Katy Dolan Baumer called the session to order at 9:00 a.m.. Also present were Management Analyst Amy Kaufholz, Facilities & Maintenance Director Steve Spejcher, Operations Manager Rick Nelson, Mr. John Bedrosian from Spaceco, Inc.. and Messrs. Vince Colella from A-Lamp, Owen Smith from Abbey Paving, Dan Murphy from Copenhagen, and Kyle Joustra from Schroeder Asphalt.

Note that Abbey included an additional excavation cost to Phase 1: Excavation to offsite 950CYx\$35.70/CY = \$33,915.00 and to Phase 4: 1,165CYx\$35.70/CY - \$41,590.50.

Director Spejcher reminded everyone present that after the bids are reviewed for accuracy and qualifications, the award will be made, hopefully within the next few days, to be brought before the Board for approval during the July 6 Board meeting. . Copies of the bidders list and the name of the selected vendor will be posted on the website and available from the Clerk's office. The session adjourned at 9:10 a.m.
