

RESOLUTION 0802162

**SETTING COMPENSATION OF ELECTED TOWNSHIP OFFICIALS
OF HANOVER TOWNSHIP, COOK COUNTY, ILLINOIS**

WHEREAS, according to 60 ILCS 1/65-20, the compensation of township officers shall be set by the township board at least 180 days before the beginning of the terms of office, or November 16, 2016; and

WHEREAS, the elective offices for Hanover Township are set for election on April 4, 2017; and

WHEREAS, pursuant to 60 ILCS 1/65-20, the compensation of township assessor shall be set by township board at the same time the board sets the compensation of its township supervisor; and

NOW THEREFORE BE IT RESOLVED by the Supervisor and the Board of Trustees of Hanover Township (the "Board"), Cook County, Illinois, that the compensation of the township officials, shall be as follows:

SECTION 1: The salaries for the offices of Hanover Township Supervisor, Township Clerk, and Trustees for the period beginning on the later of (i) the third Monday of May, 2017, or (ii) the date on which the person duly elected to such office at the Consolidated election of 2017 takes and subscribes the oath of office or affirmation prescribed by the Illinois Constitution before a person authorized to administer such oath or affirmation and gives any bond that may be required by law, and ending on April 30, 2018, and for each subsequent year thereafter until the end of their terms on May 16, 2021, are hereby set as follows:

<u>Supervisor:</u>	\$21,325.00, annually
<u>Township Clerk:</u>	\$17,483.00, annually
<u>Trustee:</u>	\$5,245.00, annually (each)

SECTION 2: The Salary for the office of Hanover Township Road District Highway Commissioner for the period beginning on the later of (i) the third Monday of May, 2017, or (ii) the date on which the person duly elected to such office at the Consolidated Election of April 2017 takes and subscribes the oath of office or affirmation prescribed by the Illinois Constitution before a person authorized to administer such oath or affirmation and gives any bond that may be required by law, and ending on April 30, 2018, and for each subsequent year thereafter until the end of the term on May 16, 2021, is hereby set as follows:

<u>Highway Commissioner:</u>	\$20,000.00, annually

SECTION 3: The salary for the office of Hanover Township Assessor for the period beginning on the later of (i) January 1, 2018, or (ii) the date on which the person duly elected to such office at the Consolidated Election of April 2017 takes and subscribes the oath of office or affirmation prescribed by the Illinois Constitution before a person authorized to administer such oath or affirmation and gives any bond that may be required by law, and ending on December 31, 2018, and for each subsequent year thereafter until the end of the term on December 31, 2021, is hereby set as follows:

Assessor: \$19,014.00, annually




